The Institute has been established with the expressed objective of promoting the general advancement of photography as an art a science, a profession; to protect and promote the interests, status, welfare and the rights and privileges of the profession of photography, amongst others.

Any person interest in photography, or in its many branches and if over the age of 21 years, can join as a member of the Institute of Sri Lankan Photographers and subsequently qualify for Licentiate Associate or Fellow and use LISLP, AISLP, or FISLP respectively after your name. An applicant over the age of 16 years could join as a Student Member.

Your membership would be ratified by the Council upon the Hony. Secretary receiving your “**Proposal for Membership**”, duly proposed and seconded by two corporate members of the Institute and forwarded together with your Admission Fee, Ordinary Membership Fee and 02 photographs of 3.5 x 4.5 cm.

The admission to membership is at the discretion of the Council and to quote the relevant section from the Constitution.

ORDINARY MEMBER

Any person interested in Photography, shall be eligible to be enrolled as an Ordinary Member and who has attained the age of 21 years.

The Council, who may reject any application without giving reason, excepting as provided by the following regulations, would ratify enrolment.

The proposal of an applicant for enrolment shall be on a prescribed Membership Proposal Form and signed by the applicant and proposed and seconded by two Corporate Members of the Institute of Sri Lankan Photographers. The list of names of applicants for membership would be displayed at an appointed place at the office or circulated to all Corporate members, at least 30 days ahead of considering the applicant for the membership by the Council. At the next meeting after the last day thereof, the Council shall proceed to consider and ratify enrolment of the applicant to Ordinary membership or otherwise, but if a notice of objection to Membership of any applicant, signed by two Corporate Members shall have been delivered to the Hony. Secretary, before expiration of the said 30 days, the Council shall not proceed with the enrolment of the applicant objected to but the Hony. Secretary shall write to the applicant informing him of the notice of objection, but not naming the signatories, and if the proposal is not withdrawn in 14 days, would be considered for membership at an Ordinary General Meeting or a Special General meeting where 3/4th of the Corporate members are present and 4/5th of those present are in favour of the applicant, such applicant shall be enrolled.

No proposal of the rejected applicant shall be considered within 12 months of rejection. Each applicant enrolled, would be informed of their enrolment to Ordinary Membership of the Institute in writing.

Your application for **Proposal for Membership** should be forwarded to the Hony. Secretary, duly perfected and together with your remittance of the Admission Fee of Rs. 500/= and Annual Membership Fee of Rs. 1,250/= (Total Rs. 1,750/=) by cash or cheque (a/c payee only) drawn in favour of the “**Institute of Sri Lankan Photographers**”, together with 2 photographs of 3.5 x 4.5 cm.
